#### **STRUCTURE OF CALLS IN 2015**

4083 calls in total were registered to the Crimestoppers hotline in 2015. Out of this number, 1529 or 37% were calls of the citizens inquiring about the ways of exercising their rights. In addition, 2099 calls or 52% were registered as unserious. The most significant calls in which the citizens provided information about criminal offences, based on which criminal reports were made and filed to competent police and other agencies, have the lowest percentage. There were 455 or 11% of these calls in 2015.

#### STRUCTURE OF INFORMATION SUBMITTED TO BH POLICE AGENCIES

455 criminal intelligence reports (4x4), which were submitted to competent police agencies in B&H, were developed in 2015. Of the total number, 90 reports were submitted to SIPA organisational units, while the rest were submitted to entity-level and cantonal MoIs, B&H Border Police and B&H Brčko District Police as well as to other agencies (Intelligence Security Agency, High Judicial and Prosecutorial Council, Indirect Taxation Authority, B&H Ministry of Justice, etc.).

Compared to 2014, during which 863 reports were made, this number was reduced by 47,8% as well as the number of criminal offences.

# OVERVIEW OF FEEDBACK INFORMATION RECEIVED FROM POLICE AGENCIES IN 2015 AND COMPARATIVE DATA FOR 2014

Following checks of allegations contained in the 2015 reports conducted by competent police agencies in B&H, 369 feedback information were received including feedback information pertaining to previous years, while the majority of information was related to information from 2015. In comparison with 2014, when 709 of feedback information were received, the number of feedback information decreased by 47, 9%.

During checks of allegations, 16 reports on the grounded suspicion of criminal offence were submitted to competent prosecutor's offices and 18 reports were submitted for evaluation and opinion. In addition, six reports were submitted for misdemeanour liability to be established.

Allegations in 29 reports were either confirmed and certain legal measures and actions were taken, while for some of them investigations were not launched and the information were retained for future operational activities or the allegations have already been known to the police agencies.

In 2014, during checks of allegations, 38 reports on the grounded suspicion of criminal offence were submitted to the competent prosecutor's offices. Additionally, 48 reports were submitted to the prosecutor's offices for evaluation and opinion. Seven reports were submitted for misdemeanour liability to be established.

In 2015, the number of reports filed on the grounded suspicion of criminal offence decreased by 57,8% in comparison with 2014, the number of reports submitted to the prosecutor's offices for evaluation decreased by 72,9% while the number of filed misdemeanour charges decreased by 14.2%.
